## **NOTICE OF PUBLIC MEETING**

*Notificación de Reunión Pública*

Notice is hereby given pursuant to the Texas Government Code, Chapter 551, as amended, that the Board of Directors of Brookshire Municipal Water District (the "District") will hold a regular meeting on **Monday, July 20, 2020, at 6:00 p.m., at 4004 6<sup>th</sup> Street, Brookshire, Texas and via telephone conference call** pursuant to Texas Government Code, Section 551.125, as amended, and as modified by the temporary suspension of various provisions thereof effective March 16, 2020, by the Governor of Texas in accordance with the Texas Disaster Act of 1975, all as related to the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas. **The telephone conference call phone number is 713-955-6338 and the Conference ID is 2371225#.** All members of the public may participate in the meeting via telephone conference call, at which meeting the following items will be discussed:

*Por la presente se notifica que de conformidad con el Código del Gobierno de Texas, Capítulo 551, según enmendado, la Junta Directiva del Distrito Municipal de Agua de Brookshire (el "Distrito") llevará a cabo una reunión programada en forma ordinaria, el lunes, 20 de julio de 2020, a las 6:00 p.m., en 4004 6th Street, Brookshire, Texas y por conferencia telefónica de conformidad con el Código de Gobierno de Texas, Sección 551.125, enmendada y modificada por la suspensión temporal de varias disposiciones del mismo a partir del 16 de marzo de 2020, por el Gobernador de Texas de conformidad con la Ley de Desastres de Texas de 1975, todo lo relacionado con la proclamación del Gobernador el 13 de marzo de 2020, certificando que la pandemia de COVID-19 plantea una amenaza inminente de desastre y declarando un estado de desastre para todos los condados en Texas.
